## COACH CODE OF CONDUCT



As a Lakes Junior Eagles Football Coach, I agree to the following:

1. I will respect the rights, dignity, and worth of every athlete and others involved in the sport and treat everyone equally.
2. I will place the welfare and safety of the athlete above the development and performance of the athlete and team.
3. I will cooperate fully with others involved in the sport such as but not limited to technical officials, team managers, other coaches, doctors, sports scientist, and representatives in the best interest of the athlete(s).
4. I will consistently promote positive aspects of the sport such as fair play and never condone rule violations or the use of prohibited or age-inappropriate substance(s).
5. I will encourage and guide athletes to accept responsibility for their own performance and behavior.
6. I will lead by example, demonstrating fair play, fair decisions, respect, and sportsmanship to all players, parents, opponents, and officials.
7. I will be knowledgeable in the rules of the sport and teach those rules to the players.
8. I will share a common goal to win, but understand the more important goal is the best interest/safety of the athlete(s) and Lakes Junior Eagles Football Organization/Program.
9. I promise to arrive at all practices and games on time or provide an appropriate excuse and coverage beforehand.

I also agree that if I fail to abide by the aforementioned rules and guidelines, I will be subject to disciplinary action that could include, but is not limited to, the following:

1. Documented verbal warning by official, head coach, Lakes Junior Eagles Football Board Member, other Lakes Junior Eagles Football member association official, or TCYFL official.
2. Written warning by any of the above to be kept on file.
3. My suspension or dismissal as a coach from the Lakes Junior Eagles Football Organization/Program.
